FOUR QUEENS

Meet Mary Lou Waterbury: Silver Strike Pioneer

Fifth in a series of articles about club members who started collecting strikes in the early days and have contributed to the club's success.

Mary Lou Waterbury and her husband, Clayton, started collecting silver strikes in 1997.

"At the Four Queens that year, I noticed the silver strike machine and pointed it out to my husband. He was immediately hooked, but it took me a little longer. We had no idea there were other silver strikes. We figured it

was a promotion only for the Four Queens," she says. Little did Mary Lou know at the time, she would later take the lead in organizing and becoming the first president of the Silver Strikers Club, and a founder of a fascinating hobby that had more than 500 members at the end of her two terms in office.

Once hooked on striking, Mary Lou and Clayton discovered other locations with strikes. They also met Ray Moritz at Winnevegas, Iowa, and he added to their knowledge many other strike locations and provided names and addresses of other collectors.

"He gave us the name of John Vilsmeier and others. We started sending out our lists of traders. Names were passed around and each person we contacted knew someone who was also interested. It was so exciting to run across someone who shared our interest," Mary Lou recalls. The late Janice O'Neill compiled a list of Nevada silver strikes, which helped to further grow their interest in strike collecting. And Clayton met Ralph Bjornson in Vegas. He provided more names. "It seemed like all over the United States there were people trading and selling silver strikes," says Mary Lou.

"I felt the need to bring us all together and form a club. I was assisted in this endeavor by Jack Haddock who offered to help me in any way he could. He and I had been going online and contacting all known collectors, asking if there was interest in forming a club. Everyone we contacted was excited about this prospect. I was working desperately with the CC>CC to obtain a room at their June 1999 convention. At first I was told there was no room, which left Jack and I to consider getting our own room or meeting out on the lawn at the Orleans. All of this was related to the CC>CC, who found that we could have a free room at 8:30 a.m. on June 17, 1999 if I could promise there would be at least 25 in the room. I promised with my fingers crossed behind my back, as we didn't have 25 signed up yet on the web page. I started getting some e-mails saying that 8:30 a.m. was too early and that time wouldn't work," says Mary Lou.

"That Wednesday morning when people started pouring into the room we knew we were onto something. I opened the meeting, welcomed everyone and, after a few remarks, turned the meeting over to Jack," she recalls.

"After determining that most of the people in the room wanted a club, a motion by Archie Black was made and seconded to set up a Silver Strike Chapter under the umbrella of the CC>CC. Interim officers selected were Jack Haddock as President and Mary Lou Waterbury as Secretary (this included being the Membership Officer). Since Jack and I were the only ones on the dais, we needed some volunteers. Evelyn Grosklaus volunteered as Treasurer. We promised to send out a bimonthly newsletter and our first would include the results of the election. That meant we needed an editor and Peter Van der Kar found himself volunteering," Mary Lou says.

"We also decided on a name, Silver Strikers, and to charge \$10 per person for dues. Some people felt that charter membership should be extended to people who had not been able to attend the meeting due to illness, etc., so it was decided to accept charter members until August 15, 1999," she says.

After the meeting, people were signing up on any scraps of paper they could find. At the end of the convention, 63 persons were bonified Charter Members.

"As people returned home and told their friends, I was getting new members daily. By August 1 we had 147 members, so we felt that was a good cut-off date. We had almost 100% of the membership send in their nominations for officers, Strike of the Year, Hall of Fame Strikes and a name for the newsletter – Silver Strikers Newsletter.

The first elected officers were: President: Mary Lou Waterbury; 1st Vice– President: Ray Moritz; 2nd Vice–President: Jack Haddock; Treasurer: Evelyn D. Grosklaus; and Secretary: Rick Andre.

Hall of Fame Strikes: \$10 Rockettes from the Flamingo; \$40 Treasure Island ship; and the \$200 Cleopatra from Caesar's Lake Tahoe.

"We were so excited to be at the helm of this new undertaking. We took an oath that we would carefully watch expenses and there were many things that all of us did that we paid for out of own pockets. We also vowed that we would carefully monitor our actions and if anything did not seem on the up and up, we would pass it by. There must be no hint of any wrongdoing on our part," says Mary Lou.

"Due to health problems I have had to either cut down my activities or drop some altogether. When able, I make the convention and attend the meetings. I still collect any strikes that are really unique or appeal to me. I think the best \$200 strike was the one from The Plaza with the Twin Towers," she says.

Mary Lou says the best part of strike collecting for her was always the chase. Once a strike was collected, they had another on their list to go after. "At first, there were so many we didn't have. At that time, most of us traded strike for strike. Strong friendships were formed. We met so many great people. My husband had a one-of-a-kind collection from almost every casino. Two people who helped make it a complete collection and refused any compensation were Ron Hartinger and Mike Watins," Mary Lou says.

"I am very concerned as membership has dropped and so few casinos are carrying the strikes. I am hoping that the loss of the casinos was not because too many people were acting like 'Ugly Americans.'" We had cautioned in most of our newsletters for strikers to treat the casino hosts, the slot fillers, the cashiers and anyone else involved in the casino strikes, as we would want to be treated. I know that as President we lost one casino due to someone acting out of line," she says.

"I am extremely proud that we started out with 63 members and kept growing. Yes, I did think that as people found out about our club that they would join and it was a heady experience finding that coming true," she recalls.

"We made so many good friends with whom we still keep in touch. Some have even stopped at our home or we have been in theirs. Some of those close friends that we lost and we mourned as one of our family are still missed. The first was Pamela Willoughby who was ill and not expected to live out the year. She was determined to make that first convention and inspired all of us who were fortunate to meet her. Then we lost Ben Kreigh of Colorado who made a list of all the silver strikes put out in that state," Mary Lou says.

"Ed Mann had suffered from cancer for nine years, would travel around the country as health permitted and get strikes for himself and others. Brian Bishop was another Charter Member who helped all of us obtain strikes and was a good friend," she added.

"One of my proudest moments was accepting the plaque for my years of service with the blue silver strike encased in it, fondly recalls Mary Lou Waterbury, our club's first President.

Board Meeting August 2009

The first board meeting of the new board was held at 6:00p.m. P.S.T. on August 13, 2009. Present for the meeting was Cheri Jollie, Becky Bottemiller, Judy Barton, Bill Jollie and invited guest Pam Martin.

The first topic discussed was about the audit that started in September 2007 during the previous Board's term. The five months that the audit was done and all the bills that were paid were all between September 2007 and February 2008. Any and all questions about the audit and expenses should be directed to the previous board.

My promise to the members of the Silver Strike Club is to provide all budget detail required to satisfy inquiry's starting with this boards approved expenses from our inauguration on Thursday, June 25, 2009 at 4:00p.m.

Second topic discussed was regarding the secretary position and asking one of our very positive members to accept the position, but before I could make the call I received an e-mail about her upcoming travels that would eliminate her. Meanwhile I will continue to do the job with all the help I can get.

The third topic was on Resident Agent. Mr. Jack Haddock has been our resident agent in Nevada for as long as we know. He has paid the \$100 annual fee and as far as I know has never billed the club. He is selling his Nevada business and will no longer be able to represent the club with this requirement. The board will be contacting the Secretary of State of Nevada to get all the information we can about this requirement.

The fourth topic was Membership. A long discussion regarding the club's membership was held by the board because of our great concern over the loss of members. Since 2006 we have had to drop 388 members, more than 200 in the past 12 months, most of those (168) in the past 6 months. As of this meeting there are 345 paid members. We discussed different options on how to increase membership and it was decided to share our plan in the next newsletter. It was noticed that three members were made associate charter members, there are four types of members including associate, the problem comes in that the constitution only allows for 140 charter members, therefore it was decided that the three members were left as associate but they were not charter so the CH was dropped from their membership number.

The Newsletter was the fifth topic and it was agreed to move the newsletter publication dates so we will have a winter, spring, summer, and fall publication. The new goal months that we hope to keep are at the end of October, end of January, April and July. The last newsletter indicated that September 1st was the deadline for articles in our first newsletter and we will need to change that date. Becky asked about classified ads. Judy is waiting on an answer from Dan and will forward it to Becky.

The next topic, #6, was melting down club coins. A discussion was held on the melting down of club coins and I will write an article for the newsletter about our ideas.

All the artwork is in and the dies should be made and hopefully on their way to gaming within the next week for approval. Perfect timing for the Drag Races in Vegas that weekend. A release time has not been set but if the strikes arrive I am sure they will be in the strike machines for the Drag Race weekend.

Palms has all 4 silver strike machines up and running with clears and reds. The artwork for their new Farrah Fawcett is at the Mint but a release time is not known. There will be a \$200 and red caps. Farrah Fawcett was a very special lady and what wonderful way to remember her with a silver strike. Craig Karnatowski is no longer at the Palms. They have a new slot director who has taken a great interest in their silver strike program and we are looking forward to some new and creative ideas in the future from the Palms.

The Melting of Club Coins

This may be your last chance to purchase older club coins. On December 31st of this year this board is planning to melt down all unsold club coins. The silver will be used to save on the cost of producing next year's club coin. At the time this article was written we have 122 coins covering 2007, 2008 and 2009 production years. If you don't have a complete set in your collection this may be your last chance to bring it up to date. Beginning next year the number of coins minted will be greatly reduced. Collectors will need to get them early. We are also considering having them numbered. We hope this will renew your desire to collect all of the club strikes. It's hard for me to believe that a striker is missing any of this most basic set of strikes.

Webmaster Brief 2009 *by Jim Quinn*

1. When Jim Moser turned over the club web site to me, he stated that one of his goals was to implement CSS (Cascading Style Sheets). To that end I have the entire site converted except Nevada casinos.
2. Current goals:
 - a. Complete CSS implementation this year.
 - b. Concurrent with CSS implementation I'm adding some PHP (PHP Hypertext Programming) to make the site easier to maintain. This requires recreating each web page on the site.
 - c. Add 20 missing casinos.
 - d. Behind the scenes I'm implementing the following:
 - i. Organizing the site into folders.
 - ii. Implementing a standardized folder and filename convention.
 - iii. Editing all images to 400 x 200 pixels (client browser will no longer need to resize images, improving display speed and image download).
 - iv. Adding fields to the strike description.
3. Future goals:
 - a. Obtain missing images for the online strike catalog.
 - b. Obtain missing information for strike text as available.
 - c. Hyperlink strike images to original full size image as submitted.
 - d. Add a History/Archive section for research/reminiscing (to include but not limited to):
 - i. Archived current news.
 - ii. Archived newsletters.
 - iii. Past club officials
 - iv. Club history.
4. Distant future goals:
 - a. Redesign the site using PHP modular approach.
 - b. Use PHP to make the site dynamic.
 - c. Implement a database online strike catalog.
